On May 24, 2022, The Empire District Electric Company d/b/a Liberty filed a tariff to implement a second Community Solar Pilot Program facility. The Commission's Staff recommended that the Commission reject the tariff. On July 21, 2022, the Commission suspended the tariff until November 29, 2022.

The Commission will order the parties to file a proposed procedural schedule, or an alternative pleading on how they wish to proceed.

THE COMMISSION ORDERS THAT:

1. The parties shall file a pleading as directed above no later than August 1, 2022.
2. This order shall be effective when issued.
