ORDER DIRECTING STAFF TO FILE RECOMMENDATION CONCERNING AMEREN MISSOURI'S SECOND COMPLIANCE FILING AND SETTING TIME FOR COMMENTS

On March 10, 2021, the Commission approved a Unanimous Stipulation and Agreement allowing Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) to establish an efficient electrification pilot program. The Commission approved Tariff No. YE-2021-0194¹ to implement the pilot program.

On April 28, 2022, Ameren Missouri filed proposed tariff revision, Tariff No. YE-2022-0251, which bears an effective date of May 28, 2022. The filing letter, which accompanied the tariff filing, states that the proposed tariff sheets implement item 11 (Reporting Requirements) of the Stipulation and Agreement approved in this case. Ameren Missouri represents that it shared the proposed tariff sheets with Staff and OPC prior to filing. Nevertheless, the Commission will direct its Staff to file a recommendation informing the Commission of whether the company's tariff revision complies with the Commission's order and the approved Stipulation and Agreement and set a time for other comments.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation regarding Ameren Missouri's compliance tariff sheets, Tariff No. YE-2022-0251, no later than May 13, 2022.
2. Any other comments about Tariff No. YE-2022-0251 are due no later than May 13, 2022.
3. This order shall be effective when issued.
