# **ORDER GRANTING APPLICATION TO INTERVENE**

On December 13, 2022, The Empire District Electric Company d/b/a Liberty (Liberty) filed an application to discontinue providing solar rebates. Liberty also requested a waiver of Commission Rule 20 CSR 4240-4.017(1) requiring a minimum of 60 days' notice prior to filing a new case with the Commission. The Commission directed notice and set a deadline of January 13, 2023, for applications to intervene.

On January 5, 2023, Renew Missouri Advocates d/b/a Renew Missouri filed a timely application to intervene. More than ten days have passed since the application was filed and no one has responded.

After considering the unopposed application to intervene, the Commission finds that Renew Missouri has interests which are different from that of the general public and allowing it to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

## THE COMMISSION ORDERS THAT:

- 1. The application to intervene of Renew Missouri is granted.
- 2. This order shall be effective when issued.
