**STAFF MOTION FOR ADDITIONAL TIME TO FILE  
STAFF RECOMMENDATION / STAFF - KCP&L STIPULATION AND AGREEMENT**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through Staff Counsel's Office, and requests additional time to file the Staff recommendation or a Staff - Kansas City Power & Light Company ("KCP&L") stipulation and agreement. In support thereof, the Staff states as follows:

1. Pursuant to 4 CSR 240-3.185(3), on August 29, 2014 KCP&L filed its Application for Approval of the Accrual and Funding of Wolf Creek Generating Station Decommissioning Costs at Current Levels ("Application").

2. On September 2, 2014, the Missouri Public Service Commission ("Commission") issued an Order Directing Staff To File A Recommendation. In said Order, the Commission directed that no later than December 1, 2014, the Staff should file a recommendation regarding KCP&L's Application. The Commission further stated that the Staff may request additional time if it is unable to offer its recommendation by that date.

3. The Staff has been working diligently on this matter but the demands of other Commission cases in addition to this matter require that the Staff request additional time until December 9, 2014 to file the Staff recommendation or a Staff - KCP&L stipulation and agreement.

4. Counsel for KCP&L and the Office of the Public Counsel ("Public Counsel") have advised undersigned counsel that KCP&L and Public Counsel have no objection to the requested grant of additional time.

**WHEREFORE**, the Staff requests additional time, until December 9, 2014, to file the Staff recommendation or a Staff - KCP&L stipulation and agreement.
