**ORDER DIRECTING FILING OF STAFF RECOMMENDATION  
REGARDING APPLICATION TO MODIFY DEMAND-SIDE PROGRAMS**

On February 10, 2017, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company ("Company") filed an application for approval to modify certain provisions of the Company's demand-side programs relating to the Technical Resource Manual and Program Incentive Ranges. The Commission will direct its Staff to review the application and submit a recommendation. The Commission will also provide an opportunity for other parties to comment on the application. Under Commission rule 4 CSR 240-20.094(4), the Commission must approve, modify, or reject the Company's application no later than March 12, 2017.

**THE COMMISSION ORDERS THAT:**

1. No later than February 22, 2017, Staff shall review the application to modify demand-side programs submitted by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company and file a recommendation as to whether the

application is in compliance with Commission rules and whether the application should be granted.

2. Any party wishing to respond or comment on the application submitted by Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company shall file its response no later than February 22, 2017.

3. This order shall be effective when issued.
