ORDER GRANTING APPLICATION TO INTERVENE

On June 22, 2016, the Missouri Department of Economic Development – Division of Energy (“DE”) filed a timely application to intervene. The Commission issued an order setting a June 28 deadline for the filing of objections to DE’s application. No objections were received.

DE is a state agency vested with the power to plan for future energy needs and energy resource development within Missouri, including the development, administration and monitoring of energy conservation programs. Commission Rule 4 CSR 240-2.075(3) authorizes the Commission to grant an application to intervene if the party has an interest different from that of the general public which may be adversely affected by a final order arising from the case, or if granting intervention would serve the public interest. DE’s intervention will serve the public interest by providing the Commission with its formal state policy and planning perspective on the efficient use of clean and affordable energy. Therefore, the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. The application by the Missouri Department of Economic Development – Division of Energy to intervene is granted.
2. This order shall be effective when issued.
