On May 12, 2022, Empire District Electric Company d/b/a Liberty filed compliance tariff sheets, Tariff No. YE-2022-0254, which bear an effective date of October 15, 2022. The Commission will direct its Staff to file a recommendation informing the Commission of whether the company’s tariff revision complies with the Commission’s orders in these matters and set a time for other comments.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation regarding Liberty’s compliance tariff sheets, Tariff No. YE-2022-0254, no later than June 18, 2022.
2. Any other comments about Tariff No. YE-2022-0254 are due no later than June 18, 2022.
3. This order shall be effective when issued.
