## SIERRA CLUB'S RESPONSE TO ORDER DIRECTING EXPEDITED FILING

Sierra Club responds to the Public Service Commission's (Commission) Order Directing Expedited Filing as follows:

- On November 2, 2020, the Commission ordered certain parties to respond to a revised List of Issues, List and Order of Witnesses, Order of Opening
   Statements, and Order of Cross-Examination filed by the Midwest Energy
   Consumers Group (MECG). The Commission noted that the newest List of Issues did not contain Issue 1(a) that the prior version of the List of Issues contained.
- 2. Midwest Energy Consumers Group later responded to the Commission's Order on November 3, 2020, and explained that Issue 1(a) was left off the revised List of Issues by mistake.
- Sierra Club agrees and advises that, for a complete list of issues, the
   Commission should use the List of Issues filed on September 9, 2020.<sup>1</sup> The
