**STAFF REPORT ON KCPL'S
2018 RENEWABLE ENERGY STANDARD COMPLIANCE REPORT**

COMES NOW the Staff of the Missouri Public Service Commission and submits its *Staff Report on KCPL's 2018 Renewable Energy Standard Compliance Report* as ordered by the Commission. In support thereof, Staff states as follows:

1. On April 15, 2019, Kansas City Power & Light Company ("KCPL" or "Company") filed its Renewable Energy Standard ("RES") Compliance Report ("2018 Compliance Report") for calendar year 2018 as required by rule. The Company also requested a limited waiver from the requirements of Rule 4 CSR 240-20.100(8)(A)1.I.(V) to substitute invoices or another reasonable substitute when meter readings are not available.¹

2. Commission rule 4 CSR 240-20.100(8) states:

...Each electric utility shall file an RES compliance report no later than April 15 to report on the status of both its compliance with the RES [renewable energy standard] and its compliance plan as described in this section for the most recently completed calendar year...

3. Rule 4 CSR 240-20.100(8)(A) specifies what information the utility must provide in its annual RES Compliance Report.

4. Rule 4 CSR 240-20.100(8)(D) provides that:

The staff of the commission shall examine each electric utility's annual RES compliance report and RES compliance plan and file a report of its review with the commission within forty-five (45) days of the filing of the annual

RES compliance report and RES compliance plan with the commission. The staff's report shall identify any deficiencies in the electric utility's compliance with the RES.

5. On April 17, 2019, the Commission issued its *Order Directing Notice And Filing*, directing the Staff to file a report of its review of the Company's 2018 Compliance Report no later than May 30, 2019.

6. Staff has conducted its review of KCPL's 2018 RES Compliance Report and has identified no deficiencies in the Company's 2018 RES Compliance Report. Staff's report is contained in its *Memorandum*, attached hereto and incorporated herein by reference.

WHEREFORE, Staff submits its report for the Commission's information and consideration regarding KCPL's 2018 RES Compliance Report.
