Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company ("Companies") provide two additional orders to the Commission which were identified in their Response to MECG Motion to Update Reply Brief and Motion to Provide Supplemental Authorities, filed on December 20, 2012:

1. Attached as Exhibit 1 is Order No. 8265 of the Delaware Public Service Commission which set a return on common equity of 9.75% in the general rate case of Delmarva Power & Light Company. See Ex. 1, Order No. 8265, ¶ 1 at p. 2, In re Delmarva Power & Light Co., No. 11-528 (Del. P.S.C., Dec. 18, 2012).

2. Attached as Exhibit 2 is the Final Decision of the Wisconsin Public Service Commission which continued to set the return on common equity of Wisconsin Electric Power Company at 10.40%. See Ex. 2, Final Decision, ¶ 97 at p. 15, In re Wisconsin Elec. Power Co. and Wisconsin Gas LLC, No. 5-UR-106 (Wis. P.S.C., Dec. 21, 2012).
