#### ORDER DIRECTING STATUS REPORT

On April 15, 2021,<sup>1</sup> Evergy Missouri West, Inc. filed its 2021 Renewable Energy Standard Compliance Plan. On June 22, the Staff of the Missouri Public Service Commission (Staff) filed its report indicating that Evergy Missouri West had met the statutory and rule requirements. In response to Staff's report, Evergy Missouri West filed a revised Compliance Plan on July 7.

On June 1, and again on July 7, the Office of the Public Counsel (OPC) made several recommendations that the Commission order certain more detailed information.

On August 2, Evergy Missouri West responded to OPC's filing at the Commission's direction.

On August 16, the OPC further responded that it seeks additional time for discovery to better understand Evergy Missouri West's position and to possibly resolve any disagreement. The OPC offered to file a status report in sixty days. The Commission finds that the request for additional time is reasonable and will grant it.

#### THE COMMISSION ORDERS THAT:

1. The OPC shall file a status report on or before October 18, 2021.
