**STAFF RECOMMENDATION TO APPROVE TARIFF SHEET**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its Recommendation that the Commission approve the tariff sheets Union Electric Company d/b/a Ameren Missouri filed that comply with the Commission’s Report and Order in this case (Tracking No. YE-2022-0025). In support Staff states as follows:

1. On September 15, 2021, the Commission issued its *Order Approving Stipulation and Agreement, Resolving Annual Fuel Adjustment Clause True-Up, and Directing Filing of Substitute Tariff*.
2. On September 16, 2021, the Commission issued its *Order Shortening Time for Responses and Directing Filing*. The Order directed Staff to review Ameren Missouri’s substitute tariff sheet and inform the Commission if it complies with the Commission’s September 15<sup>th</sup> Order no later than September 24, 2021.
3. On September 20, 2021, Ameren Missouri filed a substitute tariff sheet.
4. Staff has reviewed the substitute tariff sheet and finds that it complies with the Commission’s September 15<sup>th</sup> Order.

**WHEREFORE**, Staff recommends to the Commission that it approve the substitute tariff filed September 20, 2021, sheet to go into effect on or after October 1, 2021, the proposed effective date.


