**ORDER SHORTENING TIME FOR RESPONSES
AND DIRECTING FILING**

On May 27, 2022, Union Electric, d/b/a Ameren Missouri filed a request for a waiver of portion of its tariff setting out an Emergency Energy Conservation Procedure to be implemented when its coal supply reaches specified levels. Ameren Missouri also requested a waiver of Commission Rule 20 CSR 4240-4.017(1) requiring 60-days’ notice before filing a case with the Commission. Additionally, Ameren Missouri requested expedited treatment so that the Commission’s decision was effective no later than June 8, 2022.

Ameren Missouri represents that the Staff of the Commission and the Office of the Public Counsel do not object to the waiver. Because of the request for expedited treatment, the Commission will shorten time for responses to the request for waiver. Even though Ameren Missouri has represented that Staff does not object to the waiver, the Commission would benefit from the advice of its Staff and will direct a response.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a response regarding the request for waiver of the tariff provision no later than 8:30 a.m., June 1, 2022.

2. Any other responses to Ameren Missouri's motions shall be filed no later than 8:30 a.m., June 1, 2022.

3. This order is effective when issued.
