**STAFF RECOMMENDATION REGARDING  
COMPLIANCE TARIFF FILING NO. JE-2022-0274**

**COMES NOW** Staff of the Missouri Public Service Commission and for its recommendation regarding Union Electric Company d/b/a Ameren Missouri’s (“Ameren Missouri”) compliance tariff filing number JE-2022-0274, states as follows:

1. Pursuant to the Commission’s *Order Granting Waivers and Granting Expedited Treatment* issued on June 1, 2022, on June 9, 2022, Ameren Missouri filed its proposed compliance tariff sheets Mo. P.S.C. Schedule 6, Sheets 146 through Sheet 150 (Tariff Filing No. JE-2022-0274), with a proposed effective date of July 9, 2022. Thereafter, Ameren Missouri voluntarily extended the effective date of the proposed tariffs to August 9, 2022. Ameren Missouri later filed substitute proposed tariff language on July 8, 2022.

2. As discussed in detail in the attached Staff recommendation memorandum, Staff recommends that the Commission approve Ameren Missouri’s Compliance Tariff Filing No. JE-2022-0274, originally filed on June 9, 2022, and substituted on July 8, 2022, to go into effect for service on and after July 24, 2022, when the temporary tariff waiver and modification previously granted to Ameren Missouri in File No. EE-2022-0329 by the Commission expires.

**WHEREFORE**, Staff recommends the Commission issue an order approving the following tariff sheets, originally filed on June 9, 2022, and substituted on July 8, 2022, to

go into effect for service on and after July 24, 2022, when the temporary tariff waiver and modification previously granted to Ameren Missouri in File No. EE-2022-0329 by the Commission expires:
