**JOINT MOTION FOR EXTENSION OF TIME TO FILE JOINT LIST OF ISSUES,

In support thereof, the Parties state as follows:

1. On June 5, 2014 the Commission issued an *Order Granting Motion To Amend Procedural Schedule* in which it granted the Parties' *Joint Motion To Amend Procedural Schedule* and set July 25, 2014 as the date for the filing of *List of Issues, etc.*

2. The Parties have been working diligently on matters in File No. EO-2014-0189 including meeting in Kansas City on Tuesday, July 22, 2014, and engaging in a lengthy Thursday, July 24, 2014 conference call. Due to these activities and other Commission business, the Parties are not able at this time to file a *List of Issues, etc.*

3. The Parties now file their motion to extend the date for the filing of a *List of Issues, etc.* The Parties do not believe that moving the date for the filing of a *List of Issues, etc.* from July 25, 2014 to July 29, 2014, will hinder the scheduled proceedings.
