**THIRD STAFF PROGRESS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through undersigned counsel of the Staff Counsel's Office, and files a Third Staff Progress Report. In support thereof, the Staff states as follows:

1. On October 31, 2014, the Staff filed with the Commission a Second Staff Progress Report in which it advised the Commission that the Staff would submit to Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") a draft of the Staff Report the next week, the first week in November, and would request that KCP&L/GMO indicate if there were any portions of the report that should be redacted before the Staff provided a copy to Allconnect, Inc. ("Allconnect"). The reason for providing draft copies to KCP&L/GMO and Allconnect would be to provide them the opportunity to indicate any language they considered to be highly confidential or proprietary under the Commission's Rule 4 CSR 240-2.135 Confidential Information and offer any comments they might have in particular regarding any factual errors they might deem to be in the draft. The Staff stated that it anticipated filing its Report on December 12, 2014 containing its findings and any recommendations the Staff might have.

2. The Staff sent to KCP&L-GMO on November 7, 2014 a draft copy of the Staff's Report. KCP&L-GMO advised on November 14, 2014 that it would send a copy of the Staff Report to Allconnect for its review.

3. Since the Staff's October 31, 2014 Second Progress Report, the Staff has continued to work diligently and deliberately on its investigation of the Allconnect Direct Transfer Service Agreement between Allconnect and Great Plains Energy Services Incorporated ("GPES") on behalf of itself and its affiliates KCP&L/GMO involving among other things the transfer of KCP&L/GMO customer information to Allconnect.

4. Due to the press of other Commission cases and the Staff seeking to be as deliberate as possible in these matters, the Staff is not able to meet the December 12, 2014 date that it previously stated to the Commission. The Staff anticipates filing the Staff Report with the Commission by December 19, 2014.

**WHEREFORE**, the Staff files its Third Staff Progress Report.
