Dear Judge Dale:

On December 27, 2005 the Commission entered an Order Setting Evidentiary Hearing in which it stated that it is unable to resolve this matter on the pleadings and that a hearing would therefore be scheduled to determine the precise nature of FullTel's requested interconnection with CenturyTel. The Commission set the hearing for March 10, 2006. I will note that a motion for expedited treatment was granted early in the proceeding. On January 10, 2006, FullTel filed a Petition for a Second Prehearing in this matter.

The request for a second prehearing was filed in part for an opportunity to explore with the Commission and CenturyTel whether additional documentary information or affidavits could be filed by which to identify the precise nature of FullTel's interconnection with CenturyTel. If that information was available, a hearing could be avoided and the expedited track reserved for this case could resume.

The request for a second prehearing has not been ruled on as of this date.

Under cover of this letter I submit for filing another affidavit of Roger P. Baresel, President of FullTel. Mr. Baresel's affidavit is being filed 1) to update the Commission on recent developments, specifically that the failure to resolve this matter on an expedited basis has cost FullTel the customer who had requested service; and (2) to clarify the nature of the traffic that would have traveled through the interconnection with CenturyTel.

It is also hoped that this information will confirm for the Commission the precise nature of the traffic that is involved in this interconnection and will eliminate any need for a hearing.
