ORDER CANCELING REGISTRATION

On May 17, 2016, Hoteligent Telecommunications, Inc. ("the Company") filed a letter requesting the Commission cancel its registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the State of Missouri. The Commission granted the Company its IVoIP registration in the State of Missouri in File No. DA-2016-0240.

Staff states in its June 6, 2016, recommendation, the company notified the Commission of its intent to voluntarily relinquish its IVoIP registration.

On May 23, 2016, the Commission issued an Order Directing Staff To File A Recommendation. No objections or requests for a hearing were filed.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on the Company's request and Staff's recommendation, the Commission finds that the IVoIP registration granted to the Company, shall be canceled.
