ORDER CANCELING REGISTRATION

Issue Date: June 8, 2017

Effective Date: June 18, 2017

On May 25, 2017, Callabyte Technology, LLC (“Callabyte”) requesting the Commission cancel the company’s registration to provide Interconnected Voice over Internet Protocol service (“IVoIP”) in the State of Missouri. The Commission granted Callabyte its IVoIP registration in the State of Missouri in File No. DA-2016-0073.

On May 26, 2017, the Commission issued an Order Establishing Time to Respond allowing parties to file an objection or request a hearing no later than June 7, 2017. No objections or requests for a hearing were filed.

Staff states in its motion that the company notified the Commission that it no longer wished to retain its registration as an IVoIP provider in Missouri.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Callabyte’s notification and Staff’s motion, the Commission finds that the IVoIP registration granted to Callabyte Technology, shall be canceled.

IT IS ORDERED THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services granted to Callabyte Technology, LLC in File Number DA-2016-0073, is canceled.
2. This order shall become effective on June 18, 2017.
3. This case may be closed on June 19, 2017.
