ORDER CANCELING REGISTRATION

Issue Date: October 25, 2017

Effective Date: November 4, 2017

On September 25, 2017, deltathree, LLC filed a request for the Commission to cancel deltathree's registration to provide Interconnected Voice over Internet Protocol service ("IVoIP") in the State of Missouri. The Commission granted deltathree its IVoIP registration in the State of Missouri in File No. DA-2016-0231.

On September 28, 2017, the Commission issued an Order Establishing Time to Respond directing Staff to file a recommendation. On October 13, 2017, Staff filed a motion in support of the cancellation of deltathree's iVoIP registration. Staff stated that deltathree has ceased all operations and is no longer a business in the State of Missouri.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on deltathree's request and Staff's motion, the Commission finds that the IVoIP registration granted to deltathree, LLC, shall be canceled.

1. The registration to provide Interconnected Voice over Internet Protocol services granted to deltathree, LLC, in File Number DA-2016-0231, is canceled.
2. This order shall become effective on November 4, 2017.
3. This case may be closed on November 5, 2017.
