ORDER CANCELING IVOIP REGISTRATION

Effective Date: April 8, 2022

On February 16, 2022, Cable One VoIP LLC d/b/a Sparklight (Sparklight) filed a letter with the Commission to provide notice that it seeks to cancel its registration to provide Interconnected Voice over Internet Protocol service on a statewide basis. The Commission granted Sparklight its registration in Case No. DA-2022-0007 on July 15, 2021.

The Commission directed its Staff to respond, and on March 8, 2022, Staff filed a recommendation advising the Commission to cancel Sparklight's registration.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's recommendation, the Commission finds that the registration granted to Sparklight shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide IVoIP services granted to Cable One VoIP LLC d/b/a Sparklight in File Number DA-2022-0007, is canceled.
2. This order shall become effective on April 8, 2022.

3. This file may be closed on April 9, 2022.
