Enclosed herewith for filing with the Missouri Public Service Commission is P.S.C. MO. No. 5 Consolidated, Third Revised Sheet No. 12 which is applicable to both divisions of Laclede Gas Company ("Company").

This revised tariff sheet, which has an issue date of December 21, 2004 and an effective date of January 21, 2005, is being filed contemporaneously with the unopposed Stipulation and Agreement ("S&A") in the above-referenced case. Sheet No. 12 adjusts the infrastructure system replacement surcharge ("ISRS") in accordance with Sections 393.1009, 393.1012 and 393.1015 of the Revised Statutes of Missouri and the S&A. As reflected herein, the increase in the ISRS would increase the typical residential heating customer's bill by 17 cents per month, or approximately two-tenths of 1%.
