These cases were set for hearing beginning on November 29, 2021, with the procedural schedule requiring the filing of statements of position on November 23, and a final reconciliation on November 24. On November 22, the Commission granted a motion that cancelled the first week of the scheduled hearing and directed the parties to file statements of position regarding remaining issues by November 30, and to file a final reconciliation by December 1. On November 30, Staff, acting on behalf of itself and the other parties, filed a motion asking the Commission to further modify the remaining procedural schedule to extend the date for filing position statements to December 2, with a final reconciliation to be filed on December 3.

The motion explains that the parties continue to negotiate to resolve the remaining issues and suggest that a delay in the filing dates of the position statements and the final reconciliation would aid those negotiations. The Commission will grant that motion.

THE COMMISSION ORDERS THAT:

 The Motion to Modify Procedural Schedule to Require Position Statements on December 2 is granted.
