**ORDER APPROVING TARIFF SHEETS IN COMPLIANCE
WITH COMMISSION ORDER**

Issue Date: May 17, 2022

Effective Date: June 1, 2022

On April 6, 2022, the Commission issued its Report and Order in The Empire District Electric Company d/b/a Liberty’s (Empire) general rate proceeding. The Report and Order authorized Empire to file compliance tariff sheets to implement the terms of the Report and Order. On May 2, 2022, Empire filed Tariff Revision YE-2022-0252, with an effective date of June 1, 2022, to comply with the Report and Order. Empire also filed Tariff Revision YE-2022-0254, with an effective date of October 15, 2022, to comply with the Report and Order in this case and the stipulation and agreement approved in File No. ET-2020-0390, concerning Empire’s Transportation Electrification Pilot Program. This order does not address Tariff No. YE-2022-0254, because changes to those tariff sheets may yet occur.

The Commission ordered its Staff to file a recommendation regarding the compliance tariff sheets. On May 13, 2022, Staff recommended the Commission approve the compliance tariff sheets, Tariff No. YE-2022-0252. After reviewing the compliance tariff sheets and Staff’s recommendation, the Commission finds that tariff sheets comply with the Commission’s Report and Order. So that Empire can implement the compliance

tariff sheets on their effective date, the Commission finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Empire's compliance tariff sheets, Tariff No. YE-2022-0252, as filed May 2, 2022, and substituted on May 12, 2022, and May 13, 2022, are approved to become effective on June 1, 2022. The approved tariff sheets are:
