## ORDER SHORTENING TIME FOR REPLIES TO PUBLIC COUNSEL'S RESPONSE

The Office of the Public Counsel (OPC) filed its response to Evergy Metro, Inc. d/b/a Evergy Missouri Metro's Fuel and Purchased Power Adjustment Clause (FAC) interim tariff. The Commission allowed until October 11, 2021, for parties to respond to the interim tariff.

OPC does not oppose the rates contained in the interim tariff but desires for the tariff to take effect as quickly as possible. OPC notes that the rates from the FAC tariff, effective April 1, 2021, do not include October 2021. The rates contained in the interim tariff also do not include October 2021. The filing letter accompanying the interim tariff states: "Evergy Missouri Metro and Staff also agree that the current effective tariff rates (5th Revised Sheet No. 50.31) that went into effect on April 1, 2021, will remain in effect for an additional month through October 31, 2021." OPC suggests Evergy Missouri Metro be directed to file a substitute or new tariff sheet to be effective for customer usage beginning with the effective date of the tariff.

The Commission will shorten the time for replies to OPC's response pursuant to Commission Rule 20 CSR 4240-2.080(13).

**THE COMMISSION ORDERS THAT:**

1. Any replies to *Public Counsel's Response to Interim Tariff* shall be filed no later than October 12, 2021, at 3:00 p.m.
2. This order is effective when issued.
