#### RESOLUTION NO. 05-01

## A RESOLUTION ADOPTING THE ZONING ORDINANCE AND SUBDIVISION REGULATIONS FOR THE COUNTY OF CASS, MISSOURI.

WHEREAS, the County Planning Board and County Commission has caused a new version of the Zoning Ordinance and Subdivision Regulations to be prepared; in accordance with 64.211 et. seq. of revised Missouri State Statues; and

WHEREAS, the Zoning Ordinance and Subdivision Regulations were prepared with assistance of the consultants, Bucher, Willis & Ratliff Corporations, and written presentations, charts or other materials made a part of such plan; and

WHEREAS, proper notice was published in the official county newspaper prior to the public hearing, and the Cass County Planning Board held the hearing for the county; and

WHEREAS, the Zoning Ordinance and Subdivision Regulations and other matters identified therein were discussed; and

WHEREAS, it was moved and seconded and carried by a majority of the full membership of the Planning Board that the Ordinance be adopted as the Zoning Ordinance and Subdivision Regulations for Cass County, and that a certified copy of the Ordinance together with a written summary of the hearing thereon, be submitted to the County Clerk.
