ORDER APPROVING COMPLIANCE TARIFFS

On December 20, 2004, Union Electric Company, doing business as AmerenUE (UE), filed its application under Section 393.170, RSMo, and the Commission's Rules for a Certificate of Public Convenience and Necessity authorizing it to provide electric service to the aluminum smelting plant operated by Noranda Aluminum, Inc., in New Madrid County, Missouri, as an extension of its existing service area and system. On March 10, 2005, the Commission approved a Stipulation and Agreement and granted UE the requested relief. Thereafter, on April 25, Ameren filed proposed tariff sheets in compliance with the Commission's Order of March 10.

On May 20, the Commission's Staff filed its Memorandum and Recommendation, stating that the proposed sheets are indeed compliant with the Commission's Order and should be approved. The Commission has reviewed the proposed sheets and Staff's

Memorandum and Recommendation and is of the opinion that the proposed sheets should be approved for service rendered on and after June 1, 2005.

IT IS THEREFORE ORDERED:

1. That the proposed tariff sheets filed on April 25, 2005, by Union Electric Company, doing business as AmerenUE, designated as Tariff File No. YE-2005-0931, are approved for service rendered on and after June 1, 2005. The specific sheets approved are:
