APPLICATION TO INTERVENE OF NATIONAL GRID

COMES NOW National Grid USA ("National Grid"), pursuant to 4 C.S.R. 240-2.075 of the Missouri Public Service Commission's Rules of Practice and Procedure and the Commission's order herein issued February 14, 2003, and hereby applies for leave to intervene and become a party in the above-referenced proceeding in support of the application of Union Electric Company d/b/a Ameren UE for authority to participate in the Midwest Independent System Operator ("MISO") through a contractual relationship with GridAmerica LLC. In support of this Application, National Grid respectfully states as follows:

- 1. National Grid, a registered public utility holding company under PUHCA, has been appointed to serve as the independent Managing Member of GridAmerica LLC, and Union Electric Company is one of the three current companies participating in GridAmerica LLC under the MISO. The Federal Energy Regulatory Commission recently approved the choice of National Grid to serve as Managing Member of the GridAmerica, LLC.¹
- 2. Because the outcome of this proceeding will have a significant effect on National Grid's business operations in the Midwest, National Grid has a direct and substantial interest in the matters to be considered in this case which is different from that of the general public and

which may be adversely affected by the Commission decision in this proceeding, and which cannot be adequately represented by any other party.

- 3. The matters to be considered in this proceeding will directly impact National Grid's further development of GridAmerica LLC and integration of its focus on transmission efficiencies and associated transactions under the MISO. Therefore, granting this proposed intervention to National Grid would serve the public interest by allowing the input of the Managing Member of the GridAmerica LLC to be brought before the Commission.
