CASS COUNTY'S RESPONSE TO ORDER DIRECTING FILING AND TO OFFICE OF PUBLIC COUNSEL'S MOTION TO SUSPEND PROCEDURAL SCHEDULE

COMES NOW the County of Cass, Missouri (hereinafter Cass County), by and through its attorneys, and for its response to the Commission's order directing filing of June 28, 2005, and to the Office of Public Counsel's (OPC) recent motion to suspend the procedural schedule respectfully submits the following:

- 1. In its motion, OPC has accurately chronicled the history of this matter and its relationship to Judge Dandurand's Final Judgment in Case No. CV104-1443, Circuit Court of Cass County; and the appeal of that judgment in Case No. WD 64985, Missouri Court of Appeals, Western District. To review, Judge Dandurand entered an order by which Aquila was enjoined from constructing and operating the South Harper Plant and the Peculiar Substation. If at the end of the appellate process the judgment is affirmed, Aquila must demolish the South Harper Plant and the Peculiar Substation, both of which Aquila has continued to build under the contingency of its bond.
- 2. Cass County contended in January, 2005, that sufficient cause existed for the Commission to suspend proceedings in this case pending the outcome of the appeal of Judge

Dandurand's Final Judgment.¹ On June 21, 2005, as OPC has already reported, the Western District affirmed Judge Dandurand's judgment.

3. The Western District's opinion has added much more weight to the risk that the Commission will engage in a meaningless exercise if it does not suspend the proceedings in this matter. Cass County agrees with OPC that even though post opinion motions are available to Aquila, it is more likely than not that those motions will be denied by both the court of appeals and the Missouri Supreme Court. More than sufficient cause exists for the Commission to suspend these proceedings.

WHEREFORE, Cass County respectfully requests the Commission to grant OPC's motion and suspend all proceedings involving this application until the Final Judgment is final and unappealable.
