### **EVERGY MISSOURI METRO NOTICE**

**COMES NOW,** Evergy Metro, Inc. d/b/a Evergy Missouri Metro ("EMM" or the "Company"), by and through counsel, and provides the following *Notice* ("Notice") to the Missouri Public Service Commission ("Commission"):

1. On March 16, 2022, the Commission issued its Report and Order ("Order") stating that extraordinary revenues from Winter Storm Uri may not be excluded from an FAC pursuant to Commission Rule 20 CSR 4240-20.090(8)(A)2.A(XI). The Order gave EMM until March 31, 2022 to file an FAC adjustment tariff to comply with the Order. Simultaneous with the filing of this Notice, the Company made a substitute tariff filing in its open FAR case ("ER-2022-0206") in compliance with the Order. The proposed rate schedule in the ER-2022-0206 tariff filing bears an issue date of January 31, 2022 and an effective date of April 1, 2022.

2. The Company has included all extraordinary net revenues through December 31, 2021 resulting from Winter Storm Uri as a prior period correction within the "True-Up Amount (T)" line on the proposed tariff sheet filed in the ER-2022-0206 tariff filing. The Company has calculated additional interest through December 2021 on the monthly balances. The Company has provided the updated workpapers for review and comment to both Commission Staff and Office of Public Counsel in advance of this substitute filing and both parties have indicated their approval to proceed with the substitute tariff in Case No. ER-2022-0206.

WHEREFORE, Evergy Missouri Metro submits its Notice to the Commission.
