**EVERGY MISSOURI WEST’S CYCLE 3  
DEMAND-SIDE PROGRAM ANNUAL REPORT FOR 2022**

COMES NOW Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West” or the “Company”) and f/k/a KCP&L Greater Missouri Operations Company (“GMO”) and pursuant to 20 CSR 4240-20.093(9), files its Cycle 3 Demand-Side Program Annual Report for the program year ended December 31, 2022 and states as follows:

1. Missouri Public Service Commission’s (“Commission”) Missouri Energy Efficiency Investment Act (“MEEIA”) regulations require utilities with one or more approved demand-side programs to file a Demand-Side Program Annual Report no later than 90 days after the end of each program year.

2. **Exhibit 1 (Confidential)** to this pleading is Evergy Missouri West’s Demand-Side Program Annual Report for its Cycle 3 MEEIA programs (an Excel Workbook having multiple tabs) for program year 3 that ran from January 1, 2022 to December 31, 2022. Tab 1 of this Exhibit 1 is an index which sets forth the requirements of 20 CSR 4240-20.093(9) and indicates where the information responsive to each specific requirement can be found. **Exhibit 2** is the Declaration of Kimberly H. Winslow.

3. As required by the Commission’s regulations, the Company is serving a copy of this report on each party to its last MEEIA case, File No. EO-2019-0132 (Consolidated Case).

**WHEREFORE**, Evergy Missouri West requests that the Commission accept its Demand-Side Program Annual Report for its Cycle 3 MEEIA programs for program year 3.
