Major Merger Commitments Update

- Merger Closed June 4, 2018
- Completed voluntary severance programs consistent with no-layoffs
 - Evergy Non-Union Voluntary Exit Program (VEP)
 - Participants exiting service 2Q 2019 – 2Q 2020
 - Evergy Missouri West and Evergy Metro Generation VEP (KGVEP)
 - Participants exiting service 4Q 2019
- Working closely with Staff and OPC on independent 3rd party audit of affiliate transactions and corporate cost allocations
- Merger Integration: Conducted five update meetings with Staff & OPC
 - Submitted six quarterly staffing and contingent labor reports
 - Submitted four board presentations related to merger
- Submitted detailed journal entries related to the merger
- Submitted Goodwill impairment analysis
- Submitted monthly customer service and operational level reports to Staff

Major Merger Commitments Update – Cont.

- Submitted customer survey results
- Met with Staff to review contact center and other service quality performance
- Met with Staff, OPC, and Community Action Agencies to discuss progress to date for assisting the low-income population
- Provided \$300K to community action agencies – 2019 contribution
- Continued dialogue between Evergy Missouri Metro and Evergy Missouri West industrial customers and senior management outside of Regulatory/Governmental Affairs
- Adopted Evergy brand and renamed legacy Utilities
 - Evergy Missouri West
 - Evergy Missouri Metro
 - Evergy Kansas Metro
 - Evergy Kansas Central
 - Phase II of rebranding continues – “We are now Evergy”
 - Phase III Dec 2019 – Early 2020 – “Modern Energy Provider”

Merger Savings Highlights

- Currently tracking ahead of 2019 planned gross savings
 - Addressing headwinds including fast ramp up of savings charters
 - Preparing for 2020 merger efficiencies plans
- Savings highlights:
 - ~60% of filed efficiency charters producing savings
 - Administering voluntary employee exit programs consistent with plans including no layoffs
 - Completed Wave 1 and Wave 2 sourcing with better than plan results
 - Continuing to realize additional size and scope benefits of Evergy
 - Annual insurance procurements yielding favorable results
 - Reducing redundant support services contracts in line with plan
 - Added charters for Wolf Creek Support Centralization and VEP
 - Negotiated favorable rail and fuels management contracts
