**EVERGY MISSOURI METRO AND EVERGY MISSOURI WEST’S

**COMES NOW** Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“EMM”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“EMW”)(collectively “Evergy” or the “Company”), and for its *Motion to Correct Exhibit No. 133* (“Motion”) states as follows:

1. During the September 1, 2022 evidentiary hearing in these matters, the rebuttal testimony of Evergy witness John Spanos from Docket No. EC-2019-0200 (“0200-Rebuttal”) was admitted as Exhibit No. 133. (Tr. p. 259-261).

2.
