## ORDER SUSPENDING PROCEDURAL SCHEDULE AND DIRECTING FILING OF STATUS REPORT

On April 12, 2022, the Staff of the Commission (Staff) filed a motion to suspend the procedural schedule. The motion states that the deferral of Evergy Missouri Metro amounts related to the current jurisdictional allocation methodology should be addressed in Evergy Missouri Metro's general rate case, File No. ER-2022-0129. The motion also states that because the remaining Evergy Missouri West costs are being addressed in a securitization case, File No. EF-2022-0155, this accounting authority order case should be suspended. The motion represents that counsel for Evergy Missouri West and Evergy Missouri Metro, the Office of the Public Counsel, and Intervenors consent to the suspension. The Commission will grant the motion to suspend the procedural schedule and order a Staff to file a status report.

### THE COMMISSION ORDERS THAT:

1. The procedural schedule is suspended.
2. Staff shall file a status report on this matter no later than August 1, 2022.

3. This order is effective when issued.
