Please find enclosed an original and eight copies of materials regarding a name change for Evercom Systems, Inc. ("Evercom"). In addition to this correspondence, the Company has included the following documents: Missouri Secretary of State Amended Certificate of Authority reflecting the new name, the Company's Regulatory Contact List, and sample letter notifying the facilities the Company serves of the change in name.
