**EVERGY MISSOURI METRO'S  
MOTION TO SUPPLEMENT TESTIMONY**

COMES NOW Evergy Metro, Inc. d/b/a Evergy Missouri Metro ("Evergy Missouri Metro" or the "Company"), and submits its *Motion to Supplement Testimony* to the Missouri Public Service Commission ("Commission"). In support thereof, the Company respectfully states as follows:

1. On January 31, 2020, Evergy Missouri Metro filed a tariff revision (Tracking No. JE-2020-0122) and the supporting direct testimony of Lisa A. Starkebaum to initiate Docket No. ER-2020-0221.
2. Currently, a recommendation on the submitted tariffs from Staff ("Staff") for the Commission is due on March 1, 2020.
3. After discussions with Staff on the filing the Company is making an \$122,874 adjustment to its Fuel Adjustment Clause ("FAC") filing. The details on the adjustment are found in the supplemental testimony of Lisa A. Starkebaum, filed concurrently herewith.
4. The Company has discussed this supplemental testimony and substitute tariff sheet with Staff and Staff has indicated that it does not oppose the motion.

WHEREFORE, the Company requests the Commission issue an order approving this motion allowing the Company to supplement its testimony.
