EVERGY REQUEST FOR EXTENSION

COMES NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) (collectively, the “Company”) and for their *Request for Extension* (“Request”) state as follows:

1. Pursuant to the Missouri Public Service Commission’s (“Commission”) *Order Granting an Extension of Time to Respond to Staff’s Recommendation* (“Order”) issued on April 22, 2022, all parties’ responses to the Staff (“Staff”) *Recommendation* (“Recommendation”) filed on March 10, 2022 are due on April 28, 2022.¹

2. The Company, Staff, OPC, and Renew MO (collectively, the “Parties”) continue to actively engage in discussions concerning a possible resolution of this matter. The Parties have been conducting settlement discussions and request additional time to continue these discussions. As such, the Parties request an extension until May 5, 2022, to file a settlement agreement, or alternatively, respond to the Staff Recommendation.

3. Counsel for all parties have been apprised of the contents of this pleading and have authorized undersigned counsel to represent that no party has expressed an objection to the request made herein.

WHEREFORE, the Parties respectfully request an extension until May 5, 2022 to file a settlement agreement or, alternatively, respond to the Staff Recommendation.
