**EVERGY MISSOURI METRO’S AND EVERGY MISSOURI WEST’S  
SEMI-ANNUAL ECONOMIC DEVELOPMENT RIDER COMPLIANCE REPORT**

COME NOW Evergy Metro Inc. d/b/a Evergy Missouri Metro (“Evergy MO Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy MO West”)(collectively the “Company”)<sup>1</sup> and states the following to the Missouri Public Service Commission (“Commission”):

1. On October 31, 2018, the Commission issued its *Order Approving Stipulations and Agreements* (“Order”) in Docket Nos. ER-2018-0145 and ER-2018-0146.

2. The *Non-Unanimous Partial Stipulation and Agreement Concerning Rate Design Issues* (“Rate Design Stipulation”), as approved by the Order, states:

18. *ECONOMIC DEVELOPMENT RIDERS*

- a. *The Company will file semi-annual reports documenting compliance with EDR tariffs and statutes.*
- b. *The Company will file with Commission the actual EDR contracts upon execution, with customer names and other customer identifying information redacted. Confidential versions will be provided to Staff, OPC, DE, MIEC, and MECG subject to execution of appropriate non-disclosure agreements by Staff, OPC, DE, MIEC and MECG.*

<sup>1</sup> Effective October 7, 2019, Evergy Metro Inc. d/b/a Evergy Missouri Metro adopted the service territory and tariffs of Kansas City Power & Light Company and Evergy Missouri West, Inc. d/b/a Evergy Missouri West adopted the service territory and tariffs of KCP&L Greater Missouri Operations Company.

- c. *Filing of semi-annual reports will occur in the applicable SB 564 dockets including GMO, Case No. EO-2019-0045, and KCP&L, Case No. EO-2019-0047.*

3. Attached as **Confidential Exhibit 1**, please find the required Semi-Annual Economic Development Rider (“EDR”) Report as contemplated by Section 18 above.

**WHEREFORE**, Evergy MO Metro and Evergy MO West submit the attached as agreed to in the Rate Design Stipulation.
