## ORDER GRANTING EXTENSION OF TIME

The Empire District Electric Company d/b/a Liberty filed its triennial Integrated Resource Planning submission on April 1, 2022. On August 29, 2022, the Office of the Public Counsel filed a motion for an extension of time in which to file its report or comments as set out in 20 CSR 4240-22.080(8). Public Counsel requests a 10-day extension of time until September 8, 2022, in which to file its comments. Public Counsel states that it has discussed the extension with counsel for The Empire District Electric Company d/b/a Liberty, Staff of the Commission, Dogwood Energy, LLC, and the Missouri Department of Natural Resources-Division of Energy and none object to the extension.
