The Commission will direct its Data Center to send notice of the application to Evergy Missouri West and Platte-Clay Electrical Cooperative. The Commission will also direct the Staff of the Commission (Staff) to file a recommendation.

2. Evergy Missouri West and Platte-Clay Electrical Cooperative shall each file a response to the application no later than September 8, 2023.
3. Staff shall file its recommendation regarding the application, or a report stating when it expects to file a recommendation, no later than September 27, 2023.

5. Applicant requests the Missouri Public Service Commission to order a change

of electric provider for the following reasons.* Location: The property in
question is completely surrounded by Platte-Clay Electric
Cooperative. The main house is serviced by Evergy

by Platte-Clay. The two houses are on the 80 acre farm
which is a Missouri Century Farm that has been in
the family since 1906.

6. Applicant has taken the following steps in an attempt to work out electric

service problems with the electric service provider: Dissatisfaction with service is not the main issue. The location is the question. All the properties surrounding this location are serviced by Platte-Clay. There are no housing additions involved-- it is strictly farm land. The second house (rental) is serviced by Platte-Clay. It would be so much simpler for me (the owner of both) to have the same service for both.

WHEREFORE, Applicant requests the Missouri Public Service Commission to issue an Order which changes the current electric service provider.

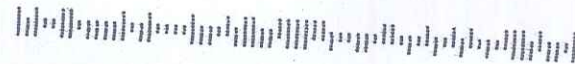

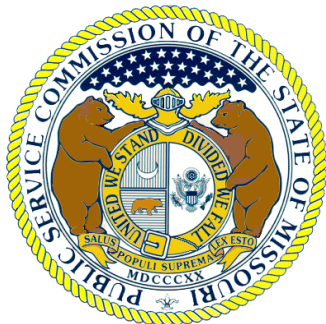
