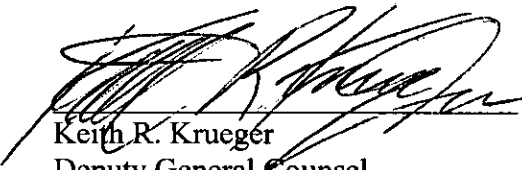

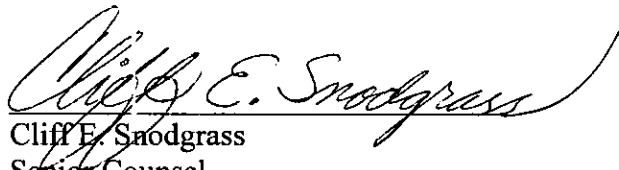
ENTRY OF APPEARANCE
