#### PUBLIC COUNSEL'S PROPOSED CUSTOMER NOTICE AND MOTION FOR LEAVE TO LATE FILE

COMES NOW the Office of the Public Counsel ("Public Counsel") and for its Proposed Customer Notice and Motion for Leave to Late File states as follows:

- 1. On October 1, 2007, The Empire District Electric Company filed a general rate case. On October 3, 2007, the Commission issued an order directing that the parties agree upon the form of notice to customers concerning the hearings in this case, and that the agreed-upon notice be filed for the Commission's approval no later than November 13, 2007.
- 2. Because of other time commitments (including NASUCA annual meetings and other Commission matters) the undersigned was not able to circulate a proposed notice for the other parties in time to meet the November 13 deadline. The proposed notice reproduced below was circulated on November 15, and all parties have indicated that they concur or do not object. Although the proposed notice indicates dates, times and locations for local public hearings, those dates, times and locations have not yet been approved by the Commission.
  - 3. The agreed-upon proposed notice is as follows:

#### **NOTICE**

On October 1, 2007, The Empire District Electric Company filed revised electric service tariff sheets with the Missouri Public Service Commission (PSC), which would increase the Company's Missouri jurisdictional annual gross revenues by approximately 10.1 percent. For a residential customer using 1,000 kilowatt-hours of electricity a month, the proposed increase would be approximately \$9.75 each month.

Local public hearings have been set before the PSC as follows:

- At 6:00 p.m., March 12, 2008, at Webster Hall, Missouri Southern State University, 3950 East Newman Road, Joplin, Missouri.
- At 12:00 p.m., March 13, 2008, at Webster Hall, Missouri Southern State University, 3950 East Newman Road, Joplin, Missouri.
- At 6:00 p.m., March 13, 2008, at Tri-Lakes TCRC, University of Missouri Extension at Reeds Spring High School, ITV Room, 20277 State Highway 413 (in the South Wing of Reeds Spring High School), Reeds Spring, Missouri.

• At 8:30 a.m., May 12 through 23, 2008, in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.
