PROCEDURAL ORDER REGARDING WORKSHOPS

On March 3, 2010, the Commission issued a procedural order adopting its Staff's proposed workshop schedule with some slight modifications. Part of that schedule included incorporating the workshops for matters related to Senate Bill 376 (Section 393.1075, RSMo Cum. Supp. 2009)¹ with the workshops for File No. EW-2009-0291, one of the Public Utilities Regulatory Policies Act files also related to energy efficiency.

The Commission has now established a separate File for the SB 376 workshop/rulemaking: File No. EW-2010-0265. The procedural schedule will remain unchanged and the consolidated workshops may continue. However, the Commission recognizes that the speed at which these workshops progress for rulemaking may vary, and separate files will be maintained for pleadings and in the event that separate workshops become a necessity.

THE COMMISSION ORDERS THAT:

- 1. All filings related to the Missouri Energy Efficiency Investment Act shall be submitted in File No. EW-2010-0265.
- 2. The Staff of the Missouri Public Service Commission shall inform the Commission of any changes in the planned consolidated workshops and notify the Commission if requirements dictate the workshops for File Nos. EW-2009-0291 and EW-2010-0265 be severed into separate forums.
