On December 2, 2015, the Commission issued an *Order Opening a Working Case Regarding Electric Vehicle Charging Facilities*, which established a deadline of June 1, 2016 for Staff to file a report of its findings and August 1, 2016 for other persons to file comments to the Staff report. On May 6, 2016 and June 24, 2016, the Commission granted Staff further extensions of those filing deadlines. On August 1, 2016, Staff requested an additional extension of time in order to include more legal analysis. The Commission finds the request reasonable and will grant it

THE COMMISSION ORDERS THAT:

1. Staff's *Motion for Extension of Time to File Report* filed on August 1, 2016, is granted.
2. The deadline for Staff to file a report of its findings and recommendations is extended until no later than August 5, 2016.
3. The deadline for other persons or entities to respond or comment on the Staff report is extended until no later than October 5, 2016.

4. This order shall be effective when issued.
