#### **NOTICE OF WORKSHOP**

**COMES NOW** the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), by and through counsel, and states the following:

1. On February 24, 2021, the Commission opened this docket to evaluate the Federal Energy Regulatory Commission's (FERC) Order 2222, regarding the regulation of distributed energy resource (DER) aggregators and their participation in the capacity, energy and ancillary service markets operated by Regional Transmission Organizations (RTO) and Independent System Operators (ISO).
