Dear Ms. Dale:

On May 19, 2006, Aquila filed two tariff sheets designed to remove limitations on the Metering Loss Adjustment as it applies to the L&P service territory. Aquila explained that failure to remove the language may eliminate the energy discounts for Large General Service and Large Power Service customers in the L&P territory that are served at higher than secondary voltage.

On June 13, 2006, the Staff filed its Recommendation to Not Approve Tariff Sheets and the Office of the Public Counsel filed its Motion to Reject Tariff or, in the Alternative, Motion to Suspend Tariff. The Commission issued its Order Suspending Tariff and Directing Notice on June 15, 2006, wherein the Commission suspending the subject tariff sheets and set this matter for a prehearing conference.

Aquila did not anticipate the strong opposition that has developed to Aquila's effort to eliminate the collection from certain customers of what Aquila believed to be unintended revenue. Aquila is not prepared to devote further resources to this effort given the resources opposing it.


