MOTION FOR SUSPENSION OF PROCEDURAL SCHEDULE

COME NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) (collectively, the “Company”) and hereby file their *Motion for Suspension of Procedural Schedule* (“Motion”).

1. On October 21, 2022, the Missouri Public Service Commission (“Commission”) issued its *Order Modifying the Procedural Schedule* (“Order”) extending deadlines as requested by the parties, and setting the deadline for simultaneous rebuttal testimony for November 2, 2022.

2. The Company and Staff (“Staff”) for the Commission have continued their settlement discussions and reached an agreement in principle that would resolve all issues in the case. Therefore, the Company requests that the Commission suspend the procedural schedule, pending the filing of a Stipulation and Agreement that would resolve all issues in the case.

3. All parties of record have been apprised of this Motion, and no party has expressed an objection.

WHEREFORE, Evergy Missouri Metro and Evergy Missouri West respectfully submit this Motion for suspension of the procedural schedule, pending finalization of a stipulation and agreement in this case.
