NOTICE OF INTENDED CASE FILING

COMES NOW, Every Missouri West, Inc. d/b/a Every Missouri West (“Every Missouri West”) and pursuant to 20 CSR 4240-4.017(1), gives notice that it intends to file an application for a certificate of public convenience and necessity (“CCN”), pursuant to Section 393.170 RSMo. and 20 CSR 4240-20.045, authorizing it to purchase, own, operate, maintain and otherwise control and manage a generation facility. The issues that may come before the Commission in this case include whether the facility is necessary or convenient to the public service. Every Missouri West may seek a waiver of this Notice requirement when it files its CCN application.

Regarding the requirement in Rule 4.017(1) that a 60-day notice of filing include “a summary of all communications regarding substantive issues likely to be in the case between the filing party and the office of the commission that occurred in the ninety (90) days prior to the filing of the notice”, the Company verifies that there have been no ex parte communications regarding issues likely to be in the noticed case between Every Missouri West and the office of the Commission within the 90 days prior to the filing of this Notice.
