



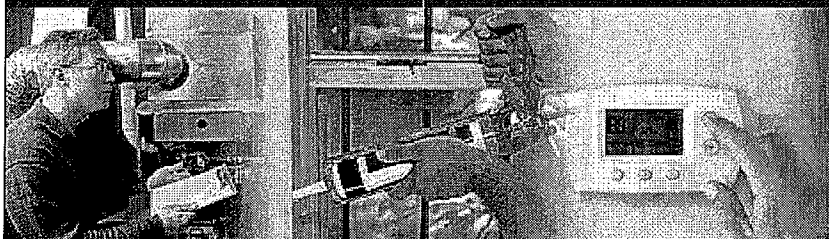

Missouri High-Efficiency System Rebate Program

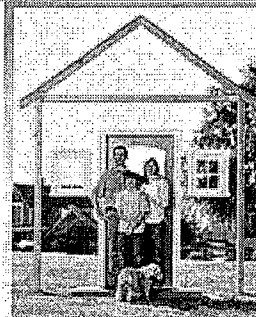

High-Efficiency Rebate Program

Eligibility

Atmos Energy's Missouri customers who are served under either the company's Residential Firm Service Rate or the Small General Service Rate may be eligible to receive a one-time rebate from Atmos Energy to replace their *existing* heating system. A customer must purchase and install a qualified ENERGY STAR® high-efficiency natural gas heating system and meet other conditions. This rebate does not apply to construction of new residential housing or commercial buildings.

Eligible participants will receive either a \$250 rebate for the purchase and installation of one ENERGY-STAR-rated furnace or boiler or a \$450 rebate for the purchase and installation of one ENERGY-STAR-rated combination heating and water heating system.

Program Guidelines

Our Missouri energy conservation program rebates are being offered on a limited basis, while funds are available, for eligible equipment purchased and installed between September 1, 2007, and August 31, 2008.

To receive your rebate you must:

- be an Atmos Energy customer located in Missouri and served under either the company's Residential Firm Service Rate or the company's Small Firm General Service Rate;
- purchase and install (within the program availability dates) eligible equipment in the building that is served by Atmos Energy under the qualified rate; and
- properly complete and submit to our program administrator, Energy Federation Incorporated, EFI, a [High-Efficiency Rebate Program Application Form \(.pdf\)](#) and a [High-Efficiency Rebate Program Installation Verification Form \(.pdf\)](#).

To be considered for this year's rebate, your new equipment must be purchased and installed by August 31, 2008. Your rebate application and installation verification forms must be submitted to the following address and be received no later than September 15, 2008. Incomplete information will delay or disqualify your rebate. Please keep a copy of the completed forms and all attachments for your records.

DO NOT SEND THE REBATE APPLICATION OR INSTALLATION VERIFICATION FORMS WITH YOUR ATMOS ENERGY BILL PAYMENT.

Upon receiving both a properly completed High-Efficiency Rebate Program Application Form and a properly completed High-Efficiency Rebate Program Installation Verification Form, EFI will issue a check to the program participant within 8 to 10 weeks.

- Missouri High-Efficiency Rebate Application Forms, High-Efficiency Rebate Program Installation Verification Forms and lists of known local ENERGY STAR retailers are available at all of Atmos Energy's Missouri offices as well as on this site or by calling the program administrator, EFI, at 1-877-333-9965.

- You will need the following information to correctly complete the rebate form: your Atmos Energy account number, one of your recent Atmos Energy utility bills, a dated purchase receipt for the eligible equipment and a proof of installation, (High-Efficiency Rebate Program Installation Verification Form).
- By applying for this rebate, you agree to allow Atmos Energy to verify the installation of any equipment covered under this program, if necessary.

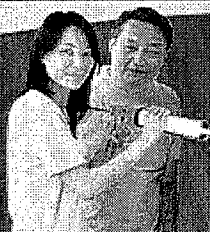

Weatherization Assistance Program

Our Missouri customers with incomes at or below 150 percent of the federal poverty levels—especially the elderly, the physically disadvantaged and families with children—may be eligible for home-weatherization assistance.

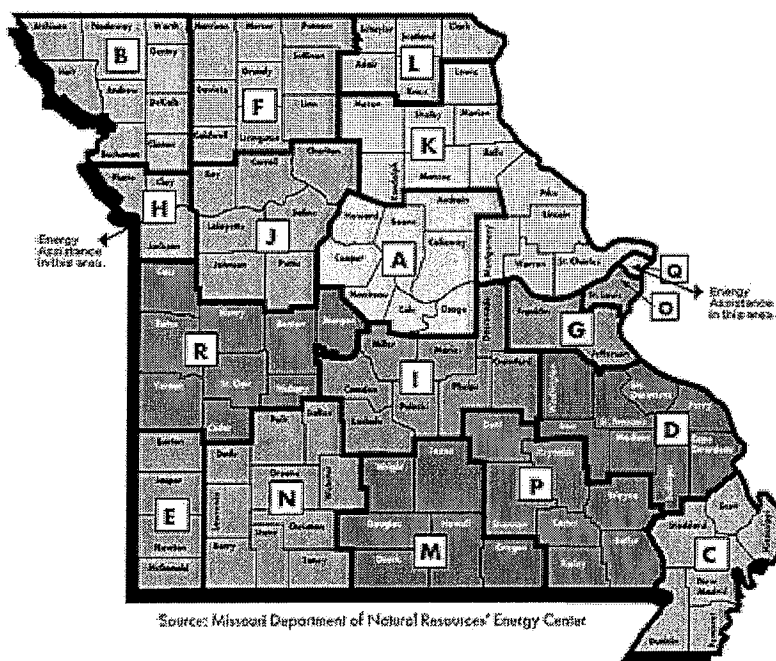
Weatherization can save natural gas users up to 30 percent on home heating costs. It can also help to lower other utility bills and make your home more comfortable. The typical improvements may include: reducing air leaks; increasing insulation in the walls, attic, floor and foundation; cleaning and tuning up the heating system; replacing the heating system; and making limited repairs to a home's structure.

The Missouri Department of Natural Resources' Energy Center administers the state's Low-Income Weatherization Program. All the work is performed by qualified local contractors and is examined by a quality-control inspector from the Department of Natural Resources to ensure completeness and quality of work.

To apply, contact your local weatherization agency by clicking on the county where you live on the map below. You will be asked to complete applications forms and to verify your income. Once you qualify, an energy auditor will inspect your home to determine what steps will produce the most savings.

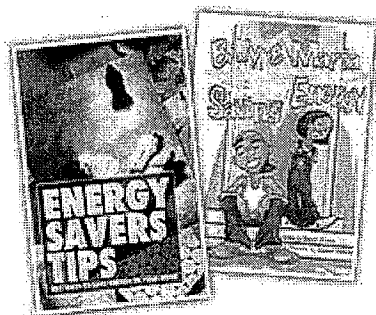
