## **STAFF STATUS REPORT**

Comes now the Staff of the Missouri Public Service Commission (Staff), by and through the Office of General Counsel, submits the following status report on behalf of itself, Union Electric Company d/b/a AmerenUE (AmerenUE), the Midwest Independent Transmission System Operator, Inc. (Midwest ISO), the Office of the Public Counsel (Public Counsel), Southwest Power Pool, Inc. (SPP), Kansas City Power & Light Company (KCPL), Aquila, Inc. (Aquila), The Empire District Electric Company (Empire) and Missouri Industrial Energy Consumers (MIEC), and states as follows:

- 1. In a January 24, 2008 Order, the Missouri Public Service Commission (Commission) scheduled a prehearing conference for February 6, 2008 for the purpose of the Commissioners asking the parties and their subject matter experts questions regarding the various filings that have been made in this case and before the Federal Energy Regulatory Commission (FERC) in Docket No. ER08-296-000. The Commissioners expressed concern in their January 24, 2008 Order that the hiatus in procedural schedule requested by AmerenUE and supported or not opposed by other parties, except the Midwest Independent Transmission System Operator, Inc. (Midwest ISO), not permit the issue to languish for several months, only to require the Commission to hastily resolve the issue thereafter when the parties are unable to do so.
  - 2. On February 6, 2008 the Commission convened the prehearing conference it had

scheduled. The Commissioners asked their questions, and the issue of whether the Commission might be in a position of being forced to hurriedly resolve the issue of AmerenUE participation in an RTO/ISO if no formal proceedings are now scheduled in EO-2008-0134 was discussed. At the conclusion of the prehearing conference on February 6, 2008, the Presiding Officer directed the parties to file a status report by February 13, 2008, which status report could, but was not required to, include a proposed procedural schedule.

- 3. At the conclusion of the prehearing conference on February 6, 2008, the parties in attendance met to discuss the Presiding Officer's directive and agreed that a procedural schedule need not be proposed or adopted at this time. The parties in attendance also agreed to hold technical conferences at AmerenUE's offices at 1901 Chouteau Avenue in St. Louis on February 22 and March 20, starting at 10:00 a.m. on both days, to which all parties are welcome to send representatives. Finally, the parties discussed their expectation that additional technical conferences would likely be held by agreement between March and June 30, which is the end of the period for which AmerenUE requested (and all other parties with the exception of the Midwest ISO either did not oppose or supported) a suspension of further proceedings in this case.
- 4. In the Status Report the Staff filed on February 13, 2008, the Staff stated that it would file another status report with the Commission by March 27, 2008 and file additional status reports periodically thereafter. Due to the press of other matters the Staff did not file its second status report by March 27, 2008, but did so March 31, 2008.
- 5. Since the Status Report the Staff filed March 31, 2008, as planned, the parties met on April 25, 2008 and further discussed quantification of the uncertainties and the impacts of those uncertainties on the cost-benefit study results. As a result of those discussions, with a view

to reaching an agreement that resolves issues in this case, on May 9, 2008 AmerenUE is to circulate in writing proposed resolutions of issues in this case, on May 16, 2008 the other parties are to circulate their written responses and then, on May 30, 2008, AmerenUE and the other parties are to meet to discuss their positions and proposals with the goal of ascertaining whether they can agree upon resolutions of all or part of the issues in this case and reduce them to mutually agreeable language to present to the Commission in a stipulation and agreement.

6. Although the Commission, on April 1, 2008, ordered the Staff to file a status report by no later than Friday, May 2, 2008, due to the press of other Commission business the Staff was unable to file this third status report until Monday, May 5, 2008.

Wherefore the Staff files the instant status report.
